### SUMMARY OF INFORMATION:

From July 1, 2012 through September 30, 2015, staff of the former Forsyth County Youth Services Department served as the coordinator to the Forsyth County Juvenile Crime Prevention Council (JCPC).

The Youth Services Department staff is no longer staffed to serve in this role. From October 1, 2016 to present, the County Manager's Office and Budget and Management Department staff have served as the coordinator.

The purpose of this item is to officially designate the Budget and Management Department staff as the coordinator for Forsyth County's JCPC.

The coordinator schedules, coordinates, and prepares minutes of the JCPC meetings, and serves as the liaison between the Forsyth County JCPC and the North Carolina Department of Public Safety, Juvenile Community Program Section.

**WHEREAS**, staff of the former Forsyth County Youth Services Department served as coordinator for the Forsyth County Juvenile Crime Prevention Council (JCPC), from July 1, 2012 through September 30, 2015; and

**WHEREAS**, the Youth Services Department is no longer staffed to serve in this capacity; and

**WHEREAS**, staff of the County Manager's Office and Budget and Management Department worked with the local Juvenile Crime Prevention Council and the North Carolina Department of Public Safety, Juvenile Community Program Section, to transfer the role of Forsyth County JCPC coordinator from the Forsyth County Youth Services Department beginning October 1, 2015.

**NOW, THEREFORE, BE IT RESOLVED** that the Forsyth County Board of Commissioners hereby authorizes Forsyth County, through its Budget and Management Department staff, to serve the role of coordinator to the Forsyth County Juvenile Crime Prevention Council beginning July 1, 2016.
