WHEREAS, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 12:00 Noon, on Thursday, July 21, 2016, for the purchase of eight 2016 compact sedans at the request of the Forsyth County General Services Department and the following bids were received:

WHEREAS, it is the recommendation of the County Manager, the County General Services Director, and the City/County Purchasing Director that a contract for the purchase of nine 2016 compact sedans be awarded to Summerlin Nissan Mall of Georgia in the total amount of \$119,763.00; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Forsyth County, that a contract for the purchase of nine 2016 compact sedans is hereby awarded to Summerlin Nissan Mall of Georgia in the total amount of \$119,763.00 and that all other bids are hereby rejected.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Summerlin Nissan Mall of Georgia for the purchase of nine 2016 compact sedans consistent with the terms outlined herein, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
