### SUMMARY OF INFORMATION:

As part of the FY19 budget process, the Board of Commissioners approved the purchase of an additional ambulance for Emergency Services by appropriating \$275,000 of fund balance at the end of FY18. This was the full cost of the ambulance including non-capital equipment and supplies which are more appropriately purchased out of the General Fund. Also as part of the FY19 budget process, \$1,300,000 was included in the FY19 Adopted Budget for vehicles, \$70,000 of which was for equipment and supplies for emergency vehicles.

The purpose of this agenda item is to transfer \$98,650 from the 2018 Motive Equipment Replacement Capital Projects Ordinance into the General Fund for the purchase of non-capital equipment and supplies. \$68,650 is to fully equip the new ambulance which includes a cardiac monitor/defibrillator, a computer, a tablet, portable radios, and other medical equipment and supplies. The remaining \$30,000 is for computer replacements for remounted ambulances (\$15,000) and equipment purchases and emergency lighting for Sheriff vehicles (\$15,000).
