On November 8, 2019, the City/County Purchasing Department received bids for the purchase of three Chevrolet 1500 pickup trucks for use by the General Services Department as follows:

**RESOLUTION AWARDING A CONTRACT FOR THE PURCHASE OF THREE
CHEVROLET 1500 PICKUP TRUCKS FOR USE BY THE GENERAL SERVICES
DEPARTMENT FROM MODERN AUTOMOTIVE NETWORK, LLC
(GENERAL SERVICES DEPARTMENT)**

WHEREAS on October 29, 2019, the City/County Purchasing Department issued bid invitations for three Chevrolet 1500 pickup trucks to be used by the Forsyth County General Services Department to 6 local and regional qualified businesses;

WHEREAS bids were received and publicly opened by the City/County Purchasing Department at 1:00 PM on Friday, November 8, 2019, for the purchase of three Chevrolet 1500 pickup trucks per bid specifications at the request of the Forsyth County General Services Department and the following bids were received:

WHEREAS the lowest bid is provided through the North Carolina Sheriff's Association Group Purchasing Program, a formally organized competitive bidding group purchasing program that offers discount prices to public agencies, compliant with N.C.G.S. 143-129(e)(3);

WHEREAS the County Manager, the County General Services Director, and the City/County Purchasing Director recommend that a contract for the purchase of three 2020 Chevrolet 1500 pickup trucks per bid specifications in the amount of \$28,224 each be awarded to Modern Automotive Network, LLC, for a total contract amount of \$84,672;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners, that a contract for the purchase of three 2020 Chevrolet 1500 pickup trucks per bid specifications is hereby awarded to Modern Automotive Network, LLC, in the total amount of \$84,672 and that all other bids are hereby rejected, and that the County Manager and Clerk to the Board are hereby authorized to execute a contract with Modern Automotive Network, LLC, for the purchase of such vehicles in a total amount of \$84,672, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
