QUALIFICATIONS TO HOLD OFFICE

1. Registered Voter
2. Twenty-one (21) years of age; NC Const., Art. VI, sec. 6 (Exceptions – 25 years of age – State Senate; NC Const., Art. II, Sec. 6)
3. Resign to run law ruled unconstitutional by Superior Court in February, 1992.
4. Affiliated with political party for 90 days by date of filing notice of candidacy (i.e. File on last day of filing, party affiliation must have been changed by November 30, 2005. GS 163-106 (b))
5. Residency Requirement (State Senate – 2 years in State, 1 year in district, NC Const., Art. II, Sec. 6); (State House, 1 year in district, NC Const., Art. II, Sec. 7); County Commissioner and Superior Court Judges must reside in the district; Congress – NC resident, do not need to reside in the district.
