Update on Items Purchased from Children's Center

JCPC Executive committee met previously and decided to accept offer of \$25K for equipment purchased by the Children's Center of Northwest North Carolina in FY2024 for Shelter no longer operating. Motion made for one-time dollars of \$25K to be used for expansion of services and not used to replace fundraising dollars.
